Trainee Solicitor Program

Approved training for the admission of Trainee Solicitors as Legal Practitioners to the Supreme Court of Queensland

Law graduates who are employed as Trainee Solicitors in 'supervised workplace experience programs' (Articles) must complete 90 hours of 'approved training' to satisfy the legal practitioner admission rules. This approved training is in addition to the competencies covered during the traineeship and **must** incorporate an Ethics component.

QUT Legal Practice is now offering:

- The **Trainee Solicitor Program (TSP)** that provides the 90 hours of 'approved training' needed to satisfy the admission rules. In addition to the compulsory Ethics component, this program allows the Trainee Solicitor to complete either 2 x 6 credit point units or 1 x 12 credit point unit from the lists below.
- **Supplementary Training.** Our course also offers supplementary training where a firm cannot provide training in all of the legislated competencies.

Trainees will be able to enrol, pay for, and complete the majority of the training on-line and are able to complete and submit work at their own pace during a 6 month period. There will be six intakes a year for each training package.
