Table A: Student contribution bands

The Government has recently passed legislation that may change the amount you pay for your student contribution amount in your Commonwealth Supported Place (CSP) from 2021. If you are a continuing student* (enrolled before 1 January 2021) studying units in disciplines with increased student contribution amounts, you will continue paying the same amount (subject to indexation) for those units as you would have, had the reforms not been implemented.

The legislation also:

- Re-introduces a 10% discount if you are an eligible student and pay your student contribution amount upfront before the census date from 2021
- Pauses the 25% FEE-HELP loan fee until 31 December 2021 for undergraduate students studying units over summer
- Reduces the 25% FEE-HELP loan fee to 20% from 1 January 2022
- Requires students to maintain a 50% overall pass rate to remain eligible for Commonwealth assistance from 2022
- Re-introduces 7 years of Student Learning Entitlement (SLE) for Commonwealth Supported Places from 2022

*You may be eligible to be considered a 'pre-2021 student' if:

- you commenced a course of study (the ongoing course) with a provider before 1 January 2021, and did not complete that course by 31 December 2020
- you completed a course of study on or before 31 December 2020 and, on or after 1 January 2021, you commence another course that relates to the earlier course and leads to an award that is an honours degree

- you were undertaking, in 2020, an enabling course and, on or after 1 January 2021, you commence another course of study that is leading to an award
- you were undertaking, in 2020, a course of study leading to an undergraduate certificate (UC) and, on or after 1 January 2021, you commence another course of study that relates to the UC course and that is leading to an award that is a bachelor degree.

You are not considered a 'pre-2021 student' if:

- you transfer to the same course but at a different university
- you are changing from a single degree to a double degree
- you are changing from a double degree to a single degree

you withdrew from your course of study and did not re-enrol in units (in the same course) with a census date prior to 1 January 2021.

Table C: International Students

You are an international student if you are not:

- an Australian citizen
- a New Zealand citizen or
- a holder of an Australian permanent resident visa or permanent humanitarian visa.

Generally international tuition fees are based on the units you study, taking into account the principal subject matter of the unit and the level of study.

Special course-based fees apply to QUT's International College courses and international study abroad students. View the cost of individual units to check the actual amount of your tuition fees.

Table E: Summer Program Tuition Fees

If you're studying in Summer Program tuition fees are charged according to the tuition fee framework for Commonwealth supported and domestic and international tuition fee paying students.

Most Summer units for domestic students are not covered by the HECS-HELP loan scheme, so if you are planning on studying over Summer and intend on deferring your fees, you will need to submit a FEE-HELP form.

Fee rates

QUT charges domestic undergraduate (including honours) and postgraduate coursework students a fee based on the number of enrolled credit points. Students are charged the fee on a pro-rata basis which is capped at the maximum fee rate for that year. International, higher degree research, corporate award, and non-award students and external units are exempt from the fee.

Table L shows example charges per unit:

Credit point value	Charge*
6 credit points	\$19.25
12 credit points	\$38.50
24 credit points	\$77
48 credit points	\$154

The maximum Student Services and Amenities Fee for 2022 is \$314.40.

The fee will be indexed annually.

Payment of the fee

Eligible students will be able to defer the fee through a loan scheme called SA-HELP.
