APPLICATION

Students are required to submit an application providing:

- Completed application form
- Current curriculum vitae (CV)

ELIGIBILITY

1. Recipients **must**
 - Be enrolled in the Bachelor of Medical Imaging (Honours) (CS48) Year 3, Semester 2 and have a minimum GPA 4.0 at the time of application.
 - Undertake a clinical placement at one of the specified Queensland X-Ray regional placement sites offered in either of the 7-week clinical placement blocks during Year 3 (May and July).

BURSARY OFFERS AND ACCEPTANCES

2. The Bursary will be offered to the four (4) highest ranked applicants.
3. An acceptance form will be provided to the successful recipients in the offer letter (email). Recipients may not be offered a Bursary for placement in their preferred location.
4. Failure to accept the Bursary by the specified due date will result in the Bursary being relinquished back to QUT and re-offered to the next highest ranked applicant.
5. The Bursary cannot be deferred.

RETAINING THE BURSARY

6. The recipient is expected to remain enrolled for the duration of the studies to retain this scholarship.
7. Recipients wishing to take a break from study must apply for, and be granted, a Leave of Absence. Bursary payments are suspended whilst students are on an approved Leave of Absence.
8. In the event of special circumstances occurring while in the receipt of this Bursary, students must contact the University Scholarships Coordinator to discuss their situation (scholarships@qut.edu.au). Special circumstances will be taken into consideration to support individual variation to the Bursary retention requirements (supporting documentary evidence may be requested).

BURSARY PAYMENT

9. The Bursary will be paid in full upon commencement of the clinical placement at a Queensland X-Ray facility.

OTHER INFORMATION

10. This Bursary is bound by the Scholarship Concurrency Policy that determines whether certain Bursary combinations can be held concurrently by a student. **This is an Industry Bursary.** Refer to the table below.

To determine if you can hold more than one scholarship, locate Scholarship Type A on the X axis and Scholarship Type B on the Y axis then slide down and across simultaneously until you reach the concurrency decision for that scholarship combination.
