

The Order of Australia Association Foundation Scholarship

Terms and conditions

Overview

The Order of Australia Association Foundation Scholarship ('*the Scholarship*') is a merit scholarship valued at \$45,000, offered to continuing domestic students. This is provided to the Participant via funds transfer to their nominated bank account.

These terms and conditions apply to Participants commencing the Scholarship in 2025. The Scholarship requires an application and is offered from Semester 2, 2025.

Purpose

The purpose of the Scholarship is to support the next generation of leaders by helping promising young Australians to achieve their potential for the benefit of future generations of Australians.

Parts	Terms and conditions
Part 1 Eligibility Requirements	 To be eligible for the Scholarship, Participants must satisfy the below eligibility requirements: Must be an Australian citizen. Must be currently enrolled in a university undergraduate degree for the first time. Must be enrolled as a full-time student at QUT (36 credit points or above) and expect to proceed to complete their course by full-time study. Must be admitted and enrolled in their second year of study, having completed 96 credit points, in one of the below <i>eligible award courses</i>: a. EV01 Bachelor of Engineering (Honours)/Master of Robotics and Artificial Intelligence b. EN01 Bachelor of Engineering (Honours)(Mechatronics), including a minor in Robotics c. Double award course with EN01 Bachelor of Engineering (Honours)(Mechatronics), having completed 96 credit points), having completed 96 credit points in the Engineering field.
Part 2 Application and Selection Criteria	 The Scholarship requires an application form. Due to the specific nature of the Scholarship, the Participant must provide: a. Curriculum Vitae (CV)/resume b. Academic transcript

	c. Written response to the selection criteria, demonstrating:
	i. High academic achievement in their university course
	ii. Superior qualities of leadership, initiative and involvement in community affairs
	iii. Need for financial assistance to benefit from the completion of their course of study
	iv. The benefits of having a mentor.
	2. The Participant may be invited to attend in an interview at QUT.
	3. Applications must:
	a. Be submitted by the closing date
	b. Include any and all supporting documentation in the correct formc. Be written in the English language.
	4. By applying for this Scholarship, the Participant warrants that they have read, understood, and agree to be bound by these terms and conditions.
	 QUT has discretion with any decisions made, in connection with this process. To the extent permitted by law, QUT has no liability to any Participant for decisions made in relation to the Scholarship.
Part 3 Value and Payment of Scholarship	1. The Scholarship is valued at \$45,000 and paid at \$22,500 per year for a standard full-time enrolment program (36 credit points or more) for a maximum of two (2) years.
	2. Participants will be provided with mentorship from a recipient of an award in the Order of Australia who is eminent in their chosen field of study.
	3. Participants will be invited to a gala Awards Ceremony associated with the Order of Australia Association's Annual Conference Dinner and presented with their Certificate by the Governor-General or her representative.
	4. Participants who complete their studies in accelerated mode or before the term of the Scholarship lapses will forfeit any remaining balance of the Scholarship.
	5. Payment is subject to the <i>Conditions of Scholarship</i> . If the Participant fails to adhere to the <i>Conditions of Scholarship</i> , payment may be suspended or terminated.
	6. Participants will receive payment by electronic transfer to their nominated bank account after the census date of each teaching period.
	 Participants enrolled in Exchange, Cross Institutional, and/or Brisbane Universities Language Alliance (BULA) units will receive payment after the census date of the Exchange, Cross Institutional, and/or BULA units.
	 Whilst every care is taken to ensure payment is correct, Participants are required to monitor payments and notify the Scholarships team (scholarships@qut.edu.au) of any over or under payments.
	9. Overpayments:
	 a. If an overpayment occurs at any time and for any reason, QUT may issue the Participant with a written notice requiring repayment of the amount overpaid ('Overpayment Notice')
	b. The Participant must pay to QUT the amount of the overpayment specified in the Overpayment Notice within ten (10) business

	days of the date of the Overpayment Notice.
	 c. QUT may, at its sole discretion, recover the overpayment specified in the Overpayment Notice from the Participant by offsetting that overpayment against any amount subsequently due to the Participant as part of their Scholarship. 10. Taxation: QUT does not withhold PAYG tax from coursework scholarship, bursary, or prize payments. It is the Participant's responsibility to check the tax implications for their scholarship, bursary, or prize and personal circumstances. Participants are encouraged to use the <u>Australian Taxation Office's scholarship decision tool</u>. For more information, visit www.ato.gov.au/individuals.
	11. Centrelink: Centrelink may include this Scholarship entitlement in any means testing for applications made for Commonwealth assistance. Participants are encouraged to check the Centrelink website for information regarding exemptions.
Part 4 Term of Scholarship	 The term of the Scholarship will be for two (2) years, based on a standard full-time enrolment program.
Part 5 Conditions of Scholarship	 Participants must achieve a minimum course (cumulative) grade point average (GPA) of 4.00 in any given teaching period to maintain the Scholarship for the next teaching period. Progression:
	a. Participants whose course (cumulative) GPA drops below 4.00 will be issued a notification that they are in breach of the <i>Conditions of Scholarship</i> but will continue to receive payment for the currently enrolled teaching period.
	b. If the Participant's course (cumulative) GPA remains below 4.00 for the following teaching period, the Scholarship may be suspended until further notice.
	3. A third academic breach may result in the termination of the Scholarship.
	4. Submission of a progress report as required.
	5. Participants must remain admitted and enrolled full-time in an eligible award course to receive payment. See <i>Eligibility Requirements</i> for the definition of eligible award course.
	6. Participants are not permitted to change their award course and continue to receive the Scholarship, unless otherwise specified in the Scholarship offer letter.
	7. Deferment of the Scholarship offer is not permitted.
	8. Participants must provide a commitment that in the years to come, and subject to their availability, they would be willing to engage with fellow Alumni, as well as the activities of the Foundation and the Order of Australia Association.
	9. Participants must attend the Round Table Conference at Admiralty House in Sydney.
	10. Payments are suspended whilst a Participant is undertaking an approved Leave of Absence. After completing their first teaching period, Participants are eligible to apply for up to two (2) years Leave of Absence

	from their award course without impacting their Scholarship entitlement.
	11. Participants who withdraw from their award course or units prior to the completion of the teaching period (i.e., no grades are recorded) may be required to return monies paid to QUT.
	12. Special circumstances will be taken into consideration to support individual variation to the <i>Conditions of Scholarship</i> . Supporting documentary evidence may be requested. Participants are encouraged to discuss their special circumstances with the Scholarships team (scholarships@qut.edu.au), Faculty, or QUT Student Services.
	13. Recipients of the Scholarship may not be able to concurrently receive another merit, cooperative, or industry scholarship, but are eligible to receive a bursary, prize, or equity scholarship, whilst in receipt of the Scholarship. Contact the Scholarships team for more information.
	14. Unsuccessful applications:
	a. QUT's decision in the awarding of the Scholarship will be final
	b. QUT is not liable for any:
	i. indirect or consequential loss; and
	 any loss of revenue, loss of profit, or loss of business opportunities, suffered by the Participant in connection with the Scholarship process whether under contract, tort (including negligence), or otherwise.
	15. The Participant accepts the Scholarship by doing the following:a. Accept the Scholarship and agree to the declaration and terms and conditions in the online offer acceptance form by the date specified
	b. Provide QUT with student bank details.
	16. If the Participant does not accept the Scholarship by the date specified in the offer letter, the Participant will forfeit the Scholarship and QUT reserves the right to allocate the Scholarship to another person.
Part 6 Under 18	1. If the Participant is under the age of 18 years, the Participant will be deemed to have obtained the permission of the Participant's parent or legal guardian to participate in the Scholarship application process and the Scholarship award and to be bound by these terms and conditions.
Part 7	Where an application is required:
General Requirements for Application Terms	 All applications become the property of QUT upon submission, upload or otherwise.
	2. Applications must be received by QUT during the application period.
	3. A student claiming to be a Participant must provide proof of identity, if required by QUT.
	4. Each Participant may be required to sign a document indicating that they have received their Scholarship payment at the time of payment.
	5. Any decision of QUT, the Scholarship sponsor or donor, in respect of all matters arising out of, or in connection with, the Scholarship is final and binding and no correspondence will be entered into. See <i>Grievances and Appeals</i> below for information on appeals.
	6. Each Participant is responsible for notifying QUT of any change to contact details during the application process and after the Scholarship

	has been awarded.
	 If the Scholarship process is interfered with in any way or is not capable of being conducted as anticipated due to any reason beyond reasonable control of QUT, QUT reserves the right, in its sole discretion, to modify, suspend, terminate, or cancel the Scholarship, as appropriate. This Scholarship and these terms and conditions are governed by the laws of Queensland.
Part 8 Termination of	QUT reserves the right to cease the Scholarship awarded to a Participant in the following circumstances:
Scholarship	 Failure to comply with the <i>Conditions of Scholarship</i>. Withdrawal from award course. Participants are advised to contact the Scholarships team (<u>scholarships@qut.edu.au</u>), Faculty, or QUT Student Services before withdrawing from their award course.
	3. Failure to enrol into an eligible award course following the completion of the approved offer deferral period.
	4. Commencing an award course at another higher education provider during the approved offer deferral period.
	5. Failure to enrol into an eligible award course following the completion of the approved Leave of Absence period.
	6. Engaging in behaviour that breaches the QUT Student Code of Conduct, where if proven would be regarded as student misconduct. The required standards of behaviour are contained within the <u>Academic Integrity</u> <u>Policy</u> , the <u>QUT Code for Responsible Conduct of Research</u> , and the <u>Acceptable Use of Information and Communications Technology</u> <u>Resources Policy</u> .
Part 9	Where the Participant intends to lodge an application for review or appeal:
Grievances and Appeals	 Review process: 1. A Participant may request a review by submitting a written request via email to <u>scholarships@qut.edu.au</u> stating the grounds for review and include relevant supporting documentation.
	 Review requests must be lodged within ten (10) working days from date of notification of original outcome.
	3. The Director (or delegate) of Student Administration will assess the original application, the information provided in the review request, and the relevant policy and legislative requirements.
	4. The Director (or delegate) will determine to confirm the original decision, amend the decision or set aside the original decision and issue a new determination based on updated rationale.
	5. Notification of the review will be provided via email within twenty (20) working days.
	Appeal process:
	Where the Participant intends to appeal the review decision:
	1. Appeals related to scholarship, bursary, and prize matters are government by these terms and conditions, the University Committee Governance Policy, and the <u>Appeals Committee Charter</u> .
	2. Where the Participant is dissatisfied with the review outcome, they may submit an appeal to <u>scholarships@qut.edu.au</u> within five (5)

	working dates of receipt of the review outcome. The appeal must state the grounds for appeal and include any relevant supporting documentation.
	 The appeal will be reviewed by the University Appeals Committee for formal consideration. The decision of the University Appeals Committee is final.
	 Where the appeal is not resolved, the Participant may seek advice or lodge a complaint with the <u>QUT Student Ombudsman</u>. The Ombudsman is responsible for administering QUT's <u>student related</u> <u>complaints policy</u>.
	 The decision of the Appeal at 3 above is final. The QUT Student Ombudsman will assess if the review process complied with QUT's established policies and procedures.
	6. Where the Participant is still dissatisfied with the outcome, the Participant has the right to seek external review from an agency such as the National Student Ombudsman. The Participant is requested to advise the QUT Student Ombudsman of the application by email <u>ombudsman@qut.edu.au</u> .
Part 10 Privacy	 By applying for the Scholarship, the Participant provides permission for their personal details to be shared with the Selection Panel. QUT collects the personal information on the Scholarship application form to assess applications and for other university purposes upon enrolment. The collection is authorised under the QUT Student Rules. Information explaining how QUT manages Participant's personal information and our practices for disclosure can be found at: www.governance.qut.edu.au/compliance/privacy/ QUT is bound by the <i>Information Privacy Act 2009</i> (Qld) ('<i>IPA</i>'), and the QUT privacy policy is available at https://www.qut.edu.au/additional/privacy and http://www.mopp.qut.edu.au/F/F_06_02.jsp. QUT will collect and use the Participant's personal information for the purposes of administering and carrying out the Scholarship and may share information with nominated third parties who require the information for the management of the Scholarship. This information will not be used for promotion and marketing purposes.
Part 11 <i>Reserving the Right</i> <i>to Amend</i>	 Without limiting any part of the Scholarship terms and conditions, QUT may: Amend or replace these terms and conditions, or any Scholarship rules or procedures, at any time and for any reason. Extend, suspend, or terminate the Scholarship or Scholarship process at any time before the Scholarship is awarded. Accept applications after the due date. At any time prior to awarding the Scholarship, disqualify any Participant from participating or exclude their offer from further consideration. Commence a new process for calling applications on a similar or different basis to that outlined in these terms and conditions. Use non-QUT personnel in assessing applications.
