The 2014 Australasian Consumer Law Roundtable will be held on Tuesday 2 December 2014, with a side event (Teaching Consumer Law) on Monday 1 December.

The Consumer Law Roundtable draws together academics, regulators, and lawyers who are researching, teaching and practising in consumer law in Australia, New Zealand and Asia. The Roundtable provides a platform for contemporary consumer law scholarship and for collectively exploring current issues in consumer law.

The theme of the 2014 Roundtable is: "Looking back, Looking forward." Australia and New Zealand have both implemented major changes in consumer and consumer credit law in recent years. In Australia, there has been the implementation of the Australian Consumer Law in 2010, and the National Consumer Credit Protection Act in 2009, with further enhancements in 2010, and 2012. In New Zealand, there has been major changes to the Consumer Guarantees Act, Fair Trading Act, and Credit Contracts and Consumer Finance Act, with these changes to be implemented progressively from 2013 to 2015. Looking forward, in Australia there are current proposals to extend the unfair terms protections to small businesses.

The Roundtable will consider whether the reforms are achieving their goals, where they may have fallen short, and what changes might still be needed. The discussion will take place in the shadow of major relevant inquiries in Australia including the Financial System Inquiry (the Murray Inquiry) and Competition Policy Review (the Harper Review) and the proposed review of the Australian Consumer Law in 2016.

Ms Delia Rickard, Deputy Chair of the Australian Competition and Consumer Commission, has agreed to give a Keynote Presentation at the Roundtable. The Roundtable will also be preceded by a 'Teaching Consumer Law Workshop', with the purpose of sharing tips, techniques, successful and innovative approaches for teaching this area of law.

There will also be an opportunity for papers presented at the Roundtable to be submitted to a special Consumer Law edition of the Queensland University of Technology Law Review, to be published in 2015. The QUT Law Review is a scholarly refereed journal, with all articles subject to double-blind peer review by independent external referees. The QUT Law Review has an open access policy, so that published research is freely available to the public. More information about the QUT Law Review is available here: https://lr.law.qut.edu.au/.

Papers for the special edition will need to be submitted to the Review by March 2015 to be considered for inclusion in this edition.

For the Teaching Consumer Law Workshop, presentations should 5-7 minutes in length, and should highlight innovative approaches, tips, techniques, or particular challenges in teaching consumer law.
