



Queensland Government Digital Leadership: Digital Project Board Governance Masterclass

The Queensland Government Customer and Digital Group and the Public Service Commission have partnered with QUTeX to design and deliver the **Queensland Government digital project board governance program**.

The program aims to equip leaders and senior executives with the competencies and tools to become effective members of digital project boards and steering committees.

The program consists of three components, designed to develop the competencies needed to successfully manage digital risk and steer digital investments.

- Element 1: **Digital Project Board Governance Basics** (micro-learning).
- Element 2: **Digital Project Board Governance Masterclass**.
- Element 3: An optional micro-credential to become an **Accredited Digital Project Board Member**.
