Developing a Roadmap for Procurement Success

Understand where your procurement/supply team currently fits within your organisation.

Overview

In today's environment doing what you have always done - even if you do it very well - is no longer acceptable. Under pressure to contain costs and produce results despite challenging circumstances, you and your procurement/supply group should continually strive to improve your operation with a view to reshaping some (or all) of the function. That means challenging and improving the philosophies, methods and processes that will make your organisation see the procurement /supply function, as a key business partner.

Learning outcomes

At completion of this course you will be able to:

- Select and understand the key elements and foundations in designing a best practice
 procurement model to improve the efficiency and effectiveness of procurement/supply in your
 organisation.
- Demonstrate knowledge to identify the procurement environment your organisation fosters, whether reactive or strategic, and optimise your business practices to best suit this environment.
- Explain the important role procurement plays in influencing organisational strategy and operation, and develop effective strategies to improve procurement's positive influence on the organisation.
- Develop a road map with internal customers, providing methodologies to engage and segment key customers to clearly prove the value that procurement can bring to the end-to-end process.

Introduction to Contract Management

Develop your understanding of common approaches to managing a variety of agreements.

Overview

This course will develop your understanding of contract management within today's complex and dynamic business environment. Contracts form the basis of many business relationships and so effective contract management is vital to ensuring deliverables are met, maximising financial performance and decreasing risk. This course provides a practical guide to managing contracts through exploration of the contract lifecycle, from tendering and negotiating to managing risk and administering contracts. It introduces the notion of sustainable relationships with suppliers through better management of the tendering and selection process, understanding of IP management, monitoring supplier performance, managing risk and resolving disagreements more effectively.



Learning outcomes

At completion of this course you will be able to:

- Demonstrate knowledge to identify the key elements of contract establishment including sourcing, contract formation, commercial contracts and key contract terms.
- Explain the important role contract management plays in relationship and performance management, including issue management and disputes, also contract administration.
- Develop a continuous improvement approach to contract management at contract closure, with recording and reflection of the lessons learned during the contract, to help identify issues that can be avoided in future contracts.

Project Management Processes and Practices

Gain the insights and skills which will allow you to build your project management capability

Overview

This module explores the fundamentals of project management and the key aspects of project control – scope, time, and cost. We will explore each of these in turn and consider their interaction on each other and the overall performance of the project.

We will define what a project is – and what project management is – as a distinct leadership and management methodology that is fundamentally different to more generic business management methodologies. You will consider how a project is defined – its scope – and how that early statement of project inclusions, exclusions and important parameters sets the basis against which we develop and deliver the project.

You will then move on to considerations of project time and how the various activities delivered as a part of the project relate to each other and dictate the overall project duration. In doing so, the concept of the critical path will be introduced. This is the path on which any delay to an activity will result in a delay to your project. While considering time and the schedule for the project, you will explore techniques for resource allocation to the schedule such that durations are representative of what needs to happen in practice.

We will consider project cost estimating techniques and the considerations a project manager must focus on before finally bringing time and cost together and exploring a commonly used technique to assess project schedule and cost performance, and estimate just how far over or under budget and how far over or under schedule the project is likely to be at completion.

Learning outcomes

- identifying the importance of a well-defined project scope and how rigorously controlled scopes are essential to successful project delivery;
- understanding that the delivery of a successful project requires the planning, integration and control of project cost and time;
- exploring components of project cost and various cost estimating techniques that can be used to develop an overall project cost estimate – or Estimate at Completion; and
- project scheduling techniques including network diagrams and Gantt charts including how to identify the critical path(s) and critical activities and determine overall project duration.



Leading Complex Projects

Improve your understanding of the role of the complex project manager who will lead highperforming project teams to deliver successful project outcomes

Overview

This module seeks to build upon your existing foundation of knowledge and skills to offer you the next level of thinking about project complexity and the competencies required to lead your team and your organisation. Project leadership goes beyond the mere mechanics of managing a project, such as building a work breakdown structure, defining schedules, managing risk or dealing with budgets. It calls for inspiring all players to accomplish the goals and objectives in a manner that meets or exceeds expectations.

Learning outcomes

At completion of this course you will have knowledge and skills in:

- new knowledge and skills to lead complex projects, starting with understanding your own leadership style, and how you interact with others.
- understand complexity more effectively by comparing the difference between your approach in complicated project and complex project environments.
- unpacking the dimensions of complexity to better understand the environment and help leaders make more effective decisions.
- examining new competencies to navigate complex adaptive systems through the application of 'systems thinking' for more holistic decision-making.

Strategically Managing Project Risk

Develop techniques to effectively manage risk in complex project management environments

Overview

The competent manager must be able to distinguish risk in a range of cognitive heuristics and biases; and political factors can impair judgement and decision-making in complex projects and organisations. This course will develop your knowledge, conceptual frameworks, and techniques to effectively manage risk in a complex project management environment and to recognise and counter the cognitive biases, political factors and other factors which can impair complex project judgement and decision-making.

Learning outcomes

- accepted risk management practices (including risk identification, analysis, and treatment).
- the implications of systems thinking upon risk management in complex project management environments.
- understanding of organisational capability management maturity models for risk nature and impact of cognitive biases on judgement and decision making in complex projects.



Strategic Procurement

Develop an understanding of contemporary procurement practices

Overview

This course develops an understanding of contemporary procurement practices. It also builds an understanding of application of strategic procurement best practices and alignment to organisational objectives.

Learning outcomes

At completion of this course you will have knowledge and skills in:

- procurement practices in the context of the operating environment.
- developing a road map for organisational procurement/supply chain success
- understanding the important role procurement plays in influencing organisational strategy and operation and develop effective strategies to improve procurement's positive influence on the organisation.
- managing customers and stakeholders within the procurement environment.

Sourcing and contracting strategies

Deliver outcomes through strategic procurement sourcing and contracting

Overview

Global complex projects and programs use many ways to deliver outcomes, including strategic procurement sourcing and contracting throughout the capability/program lifecycle. Complex project and program managers must be able to critically assess markets and appraise options for identifying and realising benefits from investments in strategic projects.

Learning outcomes

- accepted risk Management practices (including risk identification, analysis, and treatment)
- developing sourcing and contracting strategies, for domestic and international transactions.
- understanding of application of alternative strategies and contracting models, their influence on commercial partnering behaviour and impact on the delivery of outcomes.



IP Management for Procurement

Understand strategic options for managing and protecting IP effectively

Overview

This course develops understanding of the strategic options for identifying IP requirements, managing and protecting IP effectively throughout the program/project lifecycle. It will provide you with the knowledge and skills to be able appropriately manage, protect and commercially leverage intellectual property rights using recognised best practice for strategic procurement projects.

Learning outcomes

At completion of this course you will have knowledge and skills in:

- understanding the role of, and best practice management of, IP in projects.
- how to apply contemporary best practices of strategic management of IP.
- Identifying the need for technical Data and associated IP Rights across the project lifecycle.
- how to leverage IP Rights in innovation and industry capability building.

Leadership of supplier relationships

Develop essential capabilities to sustain long-term strategic relationships

Overview

It is critical that program and project leaders develop essential capabilities in being able to identify, create, build, and sustain long-term strategic relationships built on trust to ensure the success of complex projects. This course is designed to develop essential leadership and relationship management capabilities that will enable you to select, develop, maintain, performance manage and secure contractual relationships between project partners.

Learning outcomes

- understanding the range of supplier relationships and when each is most appropriate.
- applying contemporary supplier management techniques and approaches to the section of the most appropriate procurement strategy.
- building and maintaining efficient and effective supplier relationships.


