Student Guild audited financial statements

Council noted that the Student Guild audited financial statements are expected to be considered at Council's October 2023.

Award of title of Doctor of the University

Council approved that the award of Doctor of the University be conferred on the recipients in the agenda at a graduation ceremony to be determined. Council further approved for the "Guidelines for QUT Honorary Doctorate Awards" to be updated, removing reference to acting as benefactors as part of the eligibility guidelines.

Remuneration of external members on Council committees

Council approved the recommendation from Governance, Nominations and Remuneration Committee (GNRC) to extend remuneration to external members on Council committees, in recognition of the time and costs associated with committee membership and based on a preferred remuneration model, effective 1 January 2024. Council further approved consequential revisions to Council procedures, the GNRC charter, and associated delegations.

Proposed changes to the membership of Council committees

Council approved changes to the membership of Finance and Planning Committee, and Risk and Audit Committee, including the proposal to create two new committee roles and three new definitions to be included in Council Procedure 1 – Committees. In addition, Council noted the upcoming membership vacancies and approved the extension of external members' terms of office for a period of two years.

External Review of Academic Governance

Council noted the recommendations contained in the final report of the external review of academic governance at QUT and approved the recommendations for implementation.

Council performance evaluation and external review of corporate governance at QUT

Council noted that the external review of corporate governance at QUT is scheduled for September 2023 and that the external review will incorporate the biennial review of Council as prescribed in Council Procedure 1 – Committees, section 14.2.

Proposed revisions to Manual of Policies and Procedures (MOPP) A/4.1 Organisational structure

Council approved amendments to MOPP A/4.1 Organisational Structure reflecting changes in responsibilities and associated delegations for both Council and the Vice-Chancellor.

Election of Deputy Chancellor

Council approved the election of Ms Susan Rix AM as QUT Deputy Chancellor for a two-year term of office commencing on 20 October 2023.

Reconstitution of elected student members on QUT Council

Council noted the election process according to Council Procedure 7 – Conduct of Elections to elect two student members (one postgraduate and one undergraduate) to QUT Council for a term of office 1 October 2023 to 30 September 2025.
