

# John F Lynch Memorial Scholarship

# Terms and conditions

#### **Overview**

The John F Lynch Memorial Scholarship ('the Scholarship') is a merit scholarship valued at \$5,000, offered to continuing domestic students. This is provided to the Participant via funds transfer to their nominated bank account.

These terms and conditions apply to Participants commencing the Scholarship in 2025. The Scholarship requires an application and is offered from Semester 1, 2025.

## **Purpose**

The purpose of the Scholarship is to honour the memory of John Frederick Lynch, an alumnus of QUT, World War II veteran, and accomplished engineer. In 1985, John formed his own consulting engineering practice specialising in structural and civil works. It was in this practice that he began to train large numbers of architects and engineers, an interest that remained with him throughout his life. As an alumnus of QUT, he retained a strong involvement with the university's developments and maintained contact with the faculty's full range of research and commercialisation programs.

Part 1 Eligibility Requirements	To be eligible for the Scholarship, Participants must satisfy the below eligibility requirements:
	Must be an Australian citizen OR New Zealand citizen OR an Australian permanent resident OR a holder of an Australian permanent humanitarian visa.
	2. Must be undertaking their third or fourth year of full-time study in one of the below <i>eligible award courses and majors</i> in Semester 1, 2025:
	a. EN01 Bachelor of Engineering (Honours) (Civil)
	b. EN01 Bachelor of Engineering (Honours) (Civil and Construction)
	c. EN01 Bachelor of Engineering (Honours) (Civil and Environmental)
	d. EN01 Bachelor of Engineering (Honours) (Mechanical)
	3. Must have a current course (cumulative) grade point average (GPA) of 4.00 or above.
	4. Must comply with QUT's scholarship, bursary, and prize concurrency conditions.

	2. Applications must:
	a. Be submitted by the closing date
	b. Include any and all supporting documentation in the correct form
	c. Be written in the English language.
	3. By applying for this Scholarship, the Participant warrants that they have read, understood, and agree to be bound by these terms and conditions.
	4. QUT has discretion with any decisions made, in connection with this process. To the extent permitted by law, QUT has no liability to any Participant for decisions made in relation to the Scholarship.
Part 3 Value and Payment of Scholarship	1. Scholarships valued at \$5,000 are paid at \$5,000 per year for a standard full-time enrolment program (36 credit points or more) for a maximum of one (1) year. Payments are made as one-off payment and are disbursed the week after the census date of Semester 1.
	2. For the purposes of these terms and conditions, teaching period means the Semester 1 and/or 2 teaching periods, or in instances where a program of study and instruction for a unit or award course takes place in a teaching period not designated as a Semester 1 and/or 2 teaching period, the first enrolled teaching period designated in Grouped Period 1 (Semester 1 Cluster) and/or the first enrolled teaching period designated in Grouped Period 2 (Semester 2 Cluster). Payments will not be made to Participants during the Summer Program, or any teaching periods designated in Grouped Period 3 (Summer Cluster), unless otherwise specified in the Scholarship offer letter.
	3. Participants who complete their studies in accelerated mode or before the term of the Scholarship lapses will forfeit any remaining balance of the Scholarship.
	4. Payment is subject to the <i>Conditions of Scholarship</i> . If the Participant fails to adhere to the <i>Conditions of Scholarship</i> , payment may be suspended or terminated.
	5. Participants will receive payment by electronic transfer to their nominated bank account after the census date of each teaching period.
	6. Participants enrolled in Exchange, Cross Institutional, and/or Brisbane Universities Language Alliance (BULA) units will receive payment after the census date of the Exchange, Cross Institutional, and/or BULA units.
	7. Whilst every care is taken to ensure payment is correct, Participants are required to monitor payments and notify the Scholarships team (scholarships@qut.edu.au) of any over or under payments.
	8. Overpayments:
	<ul> <li>a. If an overpayment occurs at any time and for any reason, QUT may issue the Participant with a written notice requiring repayment of the amount overpaid ('Overpayment Notice')</li> </ul>
	b. The Participant must pay to QUT the amount of the overpayment

	specified in the Overpayment Notice within ten (10) business days of the date of the Overpayment Notice.  c. QUT may, at its sole discretion, recover the overpayment specified in the Overpayment Notice from the Participant by offsetting that overpayment against any amount subsequently due to the Participant as part of their Scholarship.  9. Taxation: QUT does not withhold PAYG tax from coursework scholarship, bursary, or prize payments. It is the Participant's responsibility to check the tax implications for their scholarship, bursary, or prize and personal circumstances. Participants are encouraged to use the Australian Taxation Office's scholarship decision tool. For more information, visit www.ato.gov.au/individuals.  10. Centrelink: Centrelink may include this Scholarship entitlement in any means testing for applications made for Commonwealth assistance. Participants are encouraged to check the Centrelink website for information regarding exemptions.
Part 4 Term of Scholarship	The term of the Scholarship will be for one (1) year, based on a standard full-time enrolment program.
Part 5 Conditions of Scholarship	<ol> <li>Participants must achieve a minimum course (cumulative) grade point average (GPA) of 4.0 in any given teaching period to maintain the Scholarship for the next teaching period.</li> <li>Progression:         <ol> <li>Participants whose course (cumulative) GPA drops below 4.00 will be issued a notification that they are in breach of the Conditions of Scholarship but will continue to receive payment for the currently enrolled teaching period.</li> <li>If the Participant's course (cumulative) GPA remains below 4.00 for the following teaching period, the Scholarship may be</li> </ol> </li> </ol>
	suspended until further notice.  c. A third academic breach may result in the termination of the Scholarship.
	3. Participants must remain admitted and enrolled in an eligible award course to receive payment. See Eligibility Requirements for the definition of eligible award course.
	4. Participants are not permitted to change their award course and continue to receive the Scholarship, unless otherwise specified in the Scholarship offer letter.
	5. Deferment of the Scholarship offer is not permitted.
	<ul> <li>6. Payments are suspended whilst a Participant is undertaking an approved Leave of Absence. After completing their first teaching period, Participants are eligible to apply for up to two (2) years Leave of Absence from their award course without impacting their Scholarship entitlement.</li> <li>7. Participants who withdraw from their award course or units prior to the completion of the teaching period (i.e., no grades are recorded) may be</li> </ul>
	required to return monies paid to QUT.  8. Special circumstances will be taken into consideration to support individual variation to the Conditions of Scholarship. Supporting

Participants of the Scholarship cannot concurrently receive another merit, cooperative, or industry scholarship, but are eligible to receive a
	bursary, prize, or equity scholarship, whilst in receipt of the Scholarship.  10. Participants of the Scholarship must attend an award ceremony with the Donor, provide a letter of thanks to the Donor, and consent to participate in an online news story about the Scholarship.

	13. If the Participant does not accept the Scholarship by the date specified in the offer letter, the Participant will forfeit the Scholarship and QUT reserves the right to allocate the Scholarship to another person.
Part 6 Under 18	1. If the Participant is under the age of 18 years, the Participant will be deemed to have obtained the permission of the Participant's parent or legal guardian to participate in the Scholarship application process and the Scholarship award and to be bound by these terms and conditions.

Part 8 Termination of Scholarship	<ol> <li>QUT reserves the right to cease the Scholarship awarded to a Participant in the following circumstances:</li> <li>Failure to comply with the Conditions of Scholarship.</li> <li>Withdrawal from award course. Participants are advised to contact the Scholarships team (scholarships@qut.edu.au), Faculty, or QUT Student Services before withdrawing from their award course.</li> <li>Failure to enrol into an eligible award course following the completion of the approved offer deferral period.</li> <li>Commencing an award course at another higher education provider during the approved offer deferral period.</li> <li>Failure to enrol into an eligible award course following the completion of the approved Leave of Absence period.</li> <li>Engaging in behaviour that breaches the QUT Student Code of Conduct, where if proven would be regarded as student misconduct. Most grievances are resolved informally, through discussion with the involved parties.</li> <li>Where the Participant is dissatisfied with the outcome, they may apply to the Student Ombudsman for Level Two – Formal Resolution of Grievance, or the Student Ombudsman may determine that it is appropriate to progress the matter to Level Two.</li> <li>Where the grievance is not resolved at Level Two, the Participant may request that the Vice-President (Administration) and University Registrar progress the grievance to Level Three – Formal Grievance Determination. Part 11 Reserving the Right to Amend	<ol> <li>Without limiting any part of the Scholarship terms and conditions, QUT may:</li> <li>Amend or replace these terms and conditions, or any Scholarship rules or procedures, at any time and for any reason.</li> <li>Extend, suspend, or terminate the Scholarship or Scholarship process at any time before the Scholarship is awarded.</li> <li>Accept applications after the due date.</li> <li>At any time prior to awarding the Scholarship, disqualify any Participant from participating or exclude their offer from further consideration.</li> <li>Commence a new process for calling applications on a similar or different basis to that outlined in these terms and conditions.</li> <li>Use non-QUT personnel in assessing applications.</li> </ol>
