

Oodgeroo Noonuccal Undergraduate and Postgraduate Scholarships

Terms and conditions

Overview

The Oodgeroo Noonuccal Undergraduate and Postgraduate Scholarships (*‘the Scholarship’*) is a merit scholarship valued at \$7,500 for the undergraduate students, and \$10,000 for the postgraduate students. The Scholarship is offered to commencing or continuing Aboriginal and Torres Strait Islander students. This is provided to the Participant via funds transfer to their nominated bank account.

These terms and conditions apply to Participants commencing the Scholarship in 2026. The Scholarship requires an application and is offered from Semester 1, 2026.

Purpose

The purpose of the Scholarship is to promote the pursuit of Indigenous studies through supporting the education of Indigenous people in any of the fields which related to the life and works of Oodgeroo Noonuccal. This might include literature, education, history, cultural studies, law, justice studies and race relations.

| <p>Part 1 <i>Eligibility Requirements</i></p> | <p>To be eligible for the Scholarship, Participants must satisfy the below eligibility requirements:</p> <ol style="list-style-type: none"> 1. Must be an Australian citizen OR New Zealand citizen. 2. Must be an Aboriginal and/or Torres Strait Islander Person as defined under Section 5 of the Confirmation of Aboriginal and/or Torres Strait Islander Descent Policy and have had a processing officer from the Oodgeroo Unit or Carumba Institute confirm Aboriginal and/or Torres Strait Islander descent via the Confirmation of Aboriginal and Torres Strait Islander Descent (CATSID) procedure. 3. Must not have received this Scholarship before. 4. Must be accepted or enrolled full time (minimum 36 credit points) in an undergraduate award course for the undergraduate Scholarship. 5. Must be accepted or enrolled in either part time or full time in a postgraduate award course (either a graduate diploma or a coursework or a research master’s degree) for the postgraduate Scholarship. 6. Must not be in the final semester of their studies. 7. Must comply with QUT’s scholarship, bursary, and prize concurrency conditions. |

| <p>Part 3 <i>Value and Payment of Scholarship</i></p> | <ol style="list-style-type: none"> 1. Undergraduate Scholarships valued at \$7,500 are paid at \$7,500 per year for a standard full-time enrolment program (36 credit points or more) for a maximum of one (1) year. Payments are made twice yearly (\$3,750 per teaching period) and are disbursed the week after the census date of each teaching period. 2. Postgraduate Scholarships valued at \$10,000 are paid at \$10,000 per year for a standard full-time enrolment program (36 credit points or more) for a maximum of one (1) year. Payments are made twice yearly (\$5,000 per teaching period) and are disbursed the week after the census date of each teaching period. 3. For the purposes of these terms and conditions, <i>teaching period</i> means the Semester 1 and/or 2 teaching periods, or in instances where a program of study and instruction for a unit or award course takes place in a teaching period not designated as a Semester 1 and/or 2 teaching period, the first enrolled teaching period designated in Grouped Period 1 (Semester 1 Cluster) and/or the first enrolled teaching period designated in Grouped Period 2 (Semester 2 Cluster). Payments will not be made to Participants during the Summer Program, or any teaching periods designated in Grouped Period 3 (Summer Cluster), unless otherwise specified in the Scholarship offer letter. 4. Participants who complete their studies in accelerated mode or before the term of the Scholarship lapses will forfeit any remaining balance of the Scholarship. 5. Participants for the postgraduate Scholarship enrolled in a part-time enrolment program (24 credit points or less) will receive 50% of the payment to which would be received if undertaking a standard full-time enrolment program. 6. Payment is subject to the <i>Conditions of Scholarship</i>. If the Participant fails to adhere to the <i>Conditions of Scholarship</i>, payment may be suspended or terminated. 7. Participants will receive payment by electronic transfer to their |

Participants enrolled in Exchange, Cross Institutional, and/or Brisbane Universities Language Alliance (BULA) units will receive payment after the census date of the Exchange, Cross Institutional, and/or BULA units.</p> <p>9. Whilst every care is taken to ensure payment is correct, Participants are required to monitor payments and notify the Scholarships team (scholarships@qut.edu.au) of any over or under payments.</p> <p>10. The term of the postgraduate Scholarship will be for one (1) year, based on a standard full-time enrolment program. The term of the postgraduate Scholarship will extend pro rata if the Participant enrolls in a part-time enrolment program. The maximum term permissible for the Scholarship for Participants undertaking part-time enrolment programs will be for two (2) years. |
| <p>Part 5 <i>Conditions of Scholarship</i></p> | <ol style="list-style-type: none"> Participants must achieve a minimum course (cumulative) grade point average (GPA) of 4.00 in any given teaching period to maintain the Scholarship for the next teaching period. Progression: <ol style="list-style-type: none"> Participants whose course (cumulative) GPA drops below 4.00 will be issued a notification that they are in breach of the <i>Conditions of Scholarship</i> but will continue to receive payment for the currently enrolled teaching period. If the Participant's course (cumulative) GPA remains below 4.00 for the following teaching period, the Scholarship may be suspended until further notice. |

Participants must remain admitted and enrolled in an eligible award course to receive payment. See <i>Eligibility Requirements</i> for the definition of eligible award course. 4. Participants are permitted to change their award course and continue to receive the Scholarship, unless otherwise specified in the Scholarship offer letter. 5. Deferment of the Scholarship offer is not permitted. 6. Payments are suspended whilst a Participant is undertaking an approved Leave of Absence. After completing their first teaching period, Participants are eligible to apply for up to two (2) years Leave of Absence from their award course without impacting their Scholarship entitlement. 11. Participants who withdraw from their award course or units prior to the completion of the teaching period (i.e., no grades are recorded) may be required to return monies paid to QUT. 12. Special circumstances will be taken into consideration to support individual variation to the <i>Conditions of Scholarship</i>. Supporting documentary evidence may be requested. Participants are encouraged to discuss their special circumstances with the Scholarships team (scholarships@qut.edu.au), Faculty, or QUT Student Services. 13. Participants of the Scholarship cannot concurrently receive another merit, cooperative, or industry scholarship, but are eligible to receive a bursary, prize, or equity scholarship, whilst in receipt of the Scholarship. 14. Failure to enrol into an eligible award course following the completion of the approved offer deferral period. 4. Commencing an award course at another higher education provider during the approved offer deferral period. 5. Failure to enrol into an eligible award course following the completion of the approved Leave of Absence period. 6. | <p>Part 9 <i>Grievances and Appeals</i></p> | <p>Where the Participant intends to lodge an application for a grievance:</p> <ol style="list-style-type: none"> 1. Participants should initially contact the Scholarships team (scholarships@qut.edu.au) or Student Ombudsman to undertake informal resolution of grievance prior to requesting formal resolution of grievance (Level One – Informal Resolution of Grievance). Most grievances are resolved informally, through discussion with the involved parties. 2. Where the Participant is dissatisfied with the outcome, they may apply to the Student Ombudsman for Level Two – Formal Resolution of Grievance, or the Student Ombudsman may determine that it is appropriate to progress the matter to Level Two. 3.
