

**QUT International – High School Day Event  
Terms and Conditions  
Monday 21 October 2019**

**"Promoter"** or **"QUT"** means Queensland University of Technology, 2 George Street, Brisbane, QLD, 4000. ABN 83 791 724 622; CRICOS Provider No. 00213J

### Participation

1. By participating in this Event, you (the **'Participant'**) warrant that you have read, understand and agree to be bound by these Terms and Conditions.

### Eligibility

2. To be eligible to participate in this Event, a participant must:
  - (a) be an international student currently studying Year 11 or 12 at a High school in Australia;
  - (b) if the participant is under the age of 18 years, provide a signed Parent/Guardian Consent Form to QUT. **Participation in this Event is conditional on QUT receiving a signed Parent/Guardian Consent Form for students under 18;**
  - (c) be a registered participant of QUT International High School Day Team Challenge by fully completing and submitting an event Registration Form, **by no later than Wednesday 16 October 2019 AEST ('Registration Closing Date');** and
  - (d) attend QUT International High School Day to be held at various locations on QUT's Gardens Point campus on **Monday 21 October 2019 occurring between 10.00am to 3:00pm AEST. Participants must attend the Registration at P Block, Level 4, Room 419, Gardens Point campus between 9:30am to 10.00am.**
3. An **international student** is defined as a student who is **not**:
  - a) a citizen of Australia or New Zealand; or
  - b) an Australian permanent visa holder.
4. **Australian or New Zealand Citizens, Permanent Residents, Current domestic QUT students and QUT employees and their immediate family members are not eligible to enter this Event.**
5. QUT reserves the right to, at any time, verify the eligibility of a participant (including a Participant's identity), and to disqualify a participant that does not meet the eligibility requirements set out in these Terms and Conditions. If there is a dispute as to the eligibility of a participant, QUT reserves the right, in its sole discretion to determine the eligibility of a participant.
6. If a participant is under the age of 18 years, he or she must obtain the permission of his or her parent or guardian to participate in the Event.
7. A participant may only submit **one** event Registration Form for this Event.
8. **Event Registration Forms will not be accepted after the Registration Closing Date.**
9. QUT reserves the right, at any time and in its absolute discretion, to verify the validity of an Event Registration Form, and disqualify any Registration Form that is incomplete, invalid or not submitted in accordance with these Terms and Conditions.
10. No responsibility is accepted by QUT for late, lost, incorrectly submitted or misdirected Registration Forms.
11. Registration Forms that are incomplete, indecipherable, illegible, forged, manipulated, tampered with in any way, contain any defamatory, offensive or unlawful content, or has the potential to damage the reputation of any individual, group of persons or entity, or that QUT reasonably considered do not comply with these Terms and Conditions will be deemed invalid and removed from the promotion.

### Prizes

12. During QUT International High School Day, participants have the option to compete in teams of **4 to 6 students** in the campus-wide QUT International High School Day Team Challenge activity.
13. There will be one (1) Winning team, one (1) First Runners Up team and one (1) Second Runners Up team. Each member of the Winning and Runners up teams will each receive one (1) prize, as follows:
  - (a) Members of the Winning team (First prize) will each receive one (1) x QUT hoodies and QUT Canvas bag, valued at AUD\$100;
  - (b) Members of the Second Runner Up team (Second prize) will each receive one (1) x QUT Backpacks, valued at AUD \$35; and
  - (c) Members of the Third Runner Up team (Third Prize) will each receive one (1) x QUT T-shirt and QUT cap, valued at AUD\$30.
14. QUT will determine the Winning team and the Runners Up teams based on the teams that earn the most points at the conclusion of **the Event**.
15. In the event that there is a tie, the Winning team will be determined by QUT as the team that earned the most points AND was the first of the tied teams to reach the Team Challenge finish point (P Block, Level 4 foyer).
16. QUT will announce the prize winners on stage at P Block, P419, 2 George Street, Brisbane on **Monday 21 October 2019 at 2:40pm AEST**. Following the announcements, Prize winners must identify themselves to QUT to claim their prize at P Block, P419, 2 George Street, Brisbane and may be asked to provide proof of identity and/or may be required to sign a document verifying that they have received their prize. Prize winners have up

until **5:00pm AEST** on the day of the Event to claim their prize. All unclaimed prizes after 5:00pm AEST on 21 October 2019 will be **forfeit**.

17. If a prize winner is under the age of 18 years, their prize may be awarded to the prize winner's parent or legal guardian.
