

# Westpac Young Technologists Scholarship

## Terms and conditions

### Overview

The Westpac Young Technologists Scholarship is a merit scholarship valued up to \$20,000, comprised of \$15,000 awarded directly to the scholar (\$5,000 per year, over three years) plus an additional \$5,000 to cover the cost of attending the Westpac Disruptive Leaders Program. The Scholarship is offered to commencing domestic students. This is provided to the Participant directly in the form of funds transfer to their nominated bank account.

These terms and conditions apply to Participants commencing the Scholarship in 2027. The Scholarship requires an application and is offered from Semester 1, 2027.

### Purpose

Participants of the Scholarship join the Westpac 100 Scholars Network and gain access to ongoing collaboration, networking and life-long learning opportunities.
