Council met on 12 October 2023 and considered or noted the following items.

Chair's Report

Council noted the Chair's Report where the Chancellor reported on the ranking result for the 2024 Times Higher Education (THE) World University Rankings—equal 199th internationally—and the 2023 QUT Pathways to Politics Program Q100 graduation gala event. The Chancellor advised that she recently visited the ARM Hub (Advanced Robotics for Manufacturing Hub) and had an opportunity to view the innovative robotics work and great dynamics on campus.
