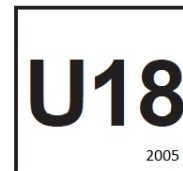

Section 1. Student visa regulations

If you are under 18 years of age, it is a requirement of Australian Government student visa regulations that you reside in Australia with one of the following options:

1. a parent or a person who has legal custody of you;
2. a person nominated by either the parent or the person having legal custody of you (must be a relative who is at least 21 years old and has the right to remain in Australia).

I acknowledge and agree that attendance in accordance with the program requirements is compulsory and that if I fail to comply with the program requirements the University may notify Department of Home Affairs that it no longer approves of my accommodation, support and general welfare arrangements.
- I acknowledge that a U18 Supervision Program fee will be charged after the commencement of my child's/ward's course.
- I, _____ (parent/legal custodian), have assessed the proposed accommodation arrangements for my child/charge and have approved them as being satisfactory to the child's needs. I acknowledge and agree that the University relies on this representation. I acknowledge and agree that the student will not change his/her accommodation, support and welfare arrangements at any time without the prior written approval of the University.

Section 10. Terms and Conditions

1. Registration with the University - All international students who will be under 18 years of age must register their proposed accommodation and welfare arrangements with the University (QUT) before they accept their offer of place by completing the relevant form. Registrations for the Under 18 Supervision Program may take several weeks, depending on the proposed accommodation arrangements.
2. Visa requirements - The Department of Home Affairs requires all international students, who will be under 18 years of age when entering Australia on a student visa, to have appropriate accommodation (QUT Homestay), support and welfare arrangements in place. When you apply for a student visa, you will need to provide evidence that you will be living with a parent, custodian or relative, or that the University has approved your care arrangements. 3. You and your parents or legal custodian must complete an application for the Under 18 Supervision Program and return this form together with all required documents and payment of the program fee to International Admissions.
4. Arrival dates – you must only arrive in Australia not more than seven (7) days before your nominated program start date.
5. Changing your accommodation and welfare arrangements - You must request written approval from QUT Homestay and the Under 18 Supervision Program before making any changes to your accommodation and welfare arrangements. If you do not maintain adequate arrangements while in Australia, your student visa may be cancelled.
6. Deferring course commencement - If you have received an offer of place from QUT, but you wish to defer commencement of your studies at the University until after you have turned 18 years of age, you will need to submit a request to QUT International Admissions.
