APPLICATION

Submission of the following documentation:

- Academic transcript which includes full name, student number and results to-date
- Proof of placement confirmation including:
 - Full name and student number
 - Name of the host school
 - Start/end dates of placement
 - o Confirmation from QUT Placement Coordinator
- Curriculum Vitae/Resume
- Professional Experience Placement Reports
- A written submission (approx. 250 words) outlining your interest in undertaking a regional, rural or remote placement and any future aspirations aligning to that. Please include a statement of any financial need (if applicable).

ELIGIBILITY

- 1. Recipients must be:-
 - Final year Bachelor of Education or Master of Teaching
 - Undertaking a professional experience placement in Semester 2, 2022
 - Professional experience placement must be in a State school campus which has a transfer rating of 2-3 and is located:
 - at least 2 hours travel time each way from their primary residence whilst at university and the host school; and
 - within a priority region including Central Queensland, Darling Downs-South West, Far North or North Queensland. Preference will be given to placements in the Far North Queensland region.

Note: transfer ratings are available using the school's directory Department of Education (eq.edu.au).

- 2. Recipients must also be one of the following:
 - an Australian or New Zealand citizen; OR
 - a permanent resident; OR
 - the holder of a permanent Humanitarian Visa; OR
 - an international student who has completed high school in Australia
- 3. Previous recipients of a Queensland Government, Beyond the Range Professional Experience Grant are eligible for this bursary.

BURSARY OFFERS AND ACCEPTANCES

- 5. This bursary cannot be deferred.

RETAINING THE BURSARY

- 6. Recipients are expected to enrol full-time for the duration of the studies to retain this bursary.
- 7. In the event of special circumstances occurring while in the receipt of this bursary, students must contact the Faculty Scholarships Coordinator to discuss their situation (ci.scholarships@qut.edu.au). Special circumstances may include cancellation of the placement. If you withdraw from this placement, you are obliged to return the funds. If the school cancels, you can retain the funds and are required to seek an alternative placement in a Tier 2-3 school will be taken into consideration to support individual variation to the scholarship retention requirements (supporting documentary evidence may be requested).

BURSARY PAYMENT

- 8. The bursary is valued at \$5,000 to cover costs associated with your professional experience placement such as transport, accommodation and incidentals.
- 9. The first instalment payment of \$2,500 will be made at the time of awarding the bursary (late July).
- 10. The second instalment payment of \$2,500 will be made after Census date in Semester 2.

OTHER INFORMATION

11. This scholarship is bound by the Scholarship Concurrency Policy that determines whether certain scholarship combinations can be held concurrently by a student. **This is a Bursary**. Refer to the table below.
