

# Corporate Partners in Excellence (CPIE) Scholarship - one year program

## **Terms and conditions**

### **Overview**

The Corporate Partners in Excellence (CPIE) Scholarship (one year program) (*'the Scholarship'*) is a unique industry-linked program offered to students undertaking a Bachelor of Business. CPIE 1-year scholars complete a semester interning with one of our prestigious corporate partners, incorporating hands-on experience with a strong academic foundation.

This a merit scholarship valued at \$14,000, offered to current domestic students. The Scholarship is provided to the Participant via funds transfer to their nominated bank account. The Scholarship requires an application and is offered from Semester 1, 2025.

The Scholarship is coordinated by the Scholarship Officer in the Faculty of Business in Law with direction from the Director of Studies in the QUT Business School.

#### Purpose

CPIE offers students a unique opportunity to apply their classroom knowledge in a professional setting. Internships with top-tier companies allow students to develop essential skills, build valuable networks, and gain firsthand experience in their chosen field.

Corporate partners benefit from the program by gaining access to a pool of talented and motivated students. These interns can bring fresh perspectives and innovative ideas to their organisations, contributing to increased productivity and growth.

By fostering strong relationships with industry partners, QUT can enhance its curriculum, create collaborative research opportunities, and improve student outcomes.
