Report from University Academic Board on academic governance activities

Council noted the key matters actioned by the University Academic Board at its 10 September 2024 meeting, including the update on a strategic academic discussion on *Queensland's University of Technology: Local footprint, regional students*; the endorsement of the disestablishment of a university research centre; results from the Student Voice Survey for Semester 1 2024; the research engagement and impact implementation; a response to a student question regarding feedback on assessment items; and a selection of reports including the half yearly reports from research ethics committees, recommendations from the external Education Services for Overseas Students (ESOS) Audit, the Curriculum Standards Committee Report, and the Research Portfolio Report.

Strategic discussion - Planning to revise Connections - the QUT Strategy 2023 to 2027 and proposed timing

Council resolved to note the discussion and presentation by Prof M Sheil, Vice-Chancellor, which outlined a plan to revise the University's strategic plan to reflect the current external environment. Council further noted plans for 2026, including new work streams, benchmarking, modelling and analysis.

Council further resolved to approve the initiative to proceed to the next phase of development, noting that preparation of a final business case was currently in development for consideration at Council at a meeting in 2025.

Council resolved to approve the proposed changes to the Management of Student Misconduct Policy to clarify access to support services following exclusion and to demonstrate compliance with the ESOS Act 2000 in relation to an assessment of an appeal.

2024 Annual Review of Register of Authorities and Delegations

Council resolved to approve the proposed revisions to Council delegations in the Register of Authorities and Delegations; to note editorial revisions relating to the Chancellery Division restructure; and to note changes to the Vice-Chancellor delegations.

Proposed changes to the QUT Commitment to Indigenous Australians Policy

Council resolved to approve the proposed changes to the QUT Commitment to Indigenous Australians Policy, which is a revision of the Reconciliation Statement, providing an opportunity to articulate in policy QUT's commitment to Indigenous Australians.
