

# McGrathNicol Indigenous Scholarship in Investigations and Intelligence

## **Terms and conditions**

### **Overview**

The McGrathNicol Indigenous Scholarship in Investigations and Intelligence (*'the Scholarship'*) is an industry scholarship valued at \$14,000, offered to commencing OR continuing domestic students. This is provided to the Participant via funds transfer to their nominated bank account.

These terms and conditions apply to Participants commencing the Scholarship in 2024. The Scholarship requires an application and is offered from Session 4, 2024.

#### **Purpose**

With the introduction of QUT's new Graduate Certificate in Investigations and Intelligence in 2024, McGrathNicol are eager to support new students entering the field of investigations who come from diverse backgrounds, and with a particular focus on supporting Indigenous Australian students.

Investigators and intelligence analysts are vital to ensure proper investigation of issues and to develop strategies and solutions that resolve public and private sector issues such as non-compliance to regulations, fraud, scams, and breaches of legislation. As the demand for professionals in investigations and intelligence fields increases, so too does the need for such professions to be inclusive and representative of the communities in which they operate.

McGrathNicol wishes to support QUT in its efforts to attract, retain, support, and develop Indigenous Australian talent, thereby creating inclusive environments that empower a strong, supportive, and diverse community.

McGrathNicol also recognises that financial challenges faced by many Indigenous Australian students when undertaking further study. This scholarship opportunity seeks to dismantle such barriers to entry.

Therefore, in the hope of fostering a more inclusive and representative workforce in the investigations and intelligence landscape, especially for Indigenous Australian people, McGrathNicol intends to establish the McGrathNicol Indigenous Scholarship in Investigations and Intelligence.

Must be an Aboriginal and/or Torres Strait Islander Person as defined under Section 5 of the <u>Confirmation of Aboriginal and/or Torres Strait</u> <u>Islander Descent Policy</u> and have had a processing officer from the Oodgeroo Unit or Carumba Institute confirm Aboriginal and/or Torres Strait Islander descent via the <u>Confirmation of Aboriginal and Torres</u> Strait Islander Descent (CATSID) procedure.</li> </ul>

	2.	Must be admitted and enrolled in one of the below <i>eligible award courses</i> :
		a. JQ20 Graduate Certificate in Investigations and Intelligence.
	3.	Must comply with QUT's scholarship, bursary, and prize concurrency conditions.
<b>Part 2</b> Application and Selection Criteria	1.	The Scholarship requires an application form. Due to the specific nature of the Scholarship, the Participant must provide:
		<ul> <li>Academic transcript and/or letter from employer supporting the Participant undertaking the JQ20 Graduate Certificate in Investigations and Intelligence award course and application for the Scholarship</li> </ul>
		b. Written response to the selection criteria:
		<ul> <li>the Participant will be required to respond in short form to a questionnaire about the Participant's professional attributes, career aspirations, interest, and intentions for studying and working in investigations and intelligence.</li> </ul>

		a. The Participant may be required to supply evidence to support claims made on their application at the interview. Where the Participant is unable to supply appropriate or compelling evidence in support of their claims, QUT reserves the right to award the Scholarship to the next highest ranked applicant.

		c. Be written in the English language.
	4.	By applying for this Scholarship, the Participant warrants that they have read, understood, and agree to be bound by these terms and conditions.
	5.	QUT has discretion with any decisions made, in connection with this process. To the extent permitted by law, QUT has no liability to any Participant for decisions made in relation to the Scholarship.
Part 3 Value and Payment of Scholarship	1.	Scholarships valued at \$14,000 are paid at \$14,000 per year for a standard full-time enrolment program (36 credit points or more) or part- time enrolment program (24 credit points or less) for a maximum of one (1) year. Payments are made per quarter (\$3,500 per teaching period) and are disbursed the week after the census date of each teaching period.
	2.	For the purposes of these terms and conditions, <i>teaching period</i> means the Session 1, 2, 3, and 4 teaching periods. Payments will not be made to Participants during the Summer Program, or any other teaching periods designated in Grouped Period 3 (Summer Cluster), unless otherwise specified in the Scholarship offer letter.
	3.	Participants who complete their studies in accelerated mode or before the term of the Scholarship lapses will forfeit any remaining balance of the Scholarship.
	4.	Participants enrolled in a part-time enrolment program will receive 100% of the payment to which would be received if undertaking a standard full-

Parts	<ul> <li>time enrolment program.</li> <li>5. Payment is subject to the <i>Conditions of Scholarship</i>. If the Participant fails to adhere to the <i>Conditions of Scholarship</i>, payment may be suspended or terminated.</li> <li>6. Participants will receive payment by electronic transfer to their nominated bank account after the census date of each teaching period.</li> <li>7. Participants enrolled in Exchange, Cross Institutional, and/or Brisbane Universities Language Alliance (BULA) units will receive payment after the census date of the Exchange, Cross Institutional, and/or BULA units.</li> <li>8. Whilst every care is taken to ensure payment is correct, Participants are required to monitor payments and notify the Scholarships team (scholarships@qut.edu.au) of any over or under payments.</li> <li>9. Overpayments: <ul> <li>a. If an overpayment occurs at any time and for any reason, QUT may issue the Participant with a written notice requiring repayment of the amount overpaid ('Overpayment Notice')</li> <li>b. The Participant must pay to QUT the amount of the overpayment specified in the Overpayment Notice.</li> <li>c. Part 4 Term of Scholarship	<ol> <li>The term of the Scholarship will be for one (1) year, for both a standard full-time enrolment program and part-time enrolment program.</li> </ol>
Part 5 Conditions of Scholarship	<ol> <li>Participants must remain admitted and enrolled in an eligible award course to receive payment. See <i>Eligibility Requirements</i> for the definition of eligible award course.</li> <li>Participants are not permitted to change their award course and continue to receive the Scholarship, unless otherwise specified in the Scholarship offer letter.</li> <li>Deferment of the Scholarship offer is not permitted.</li> <li>Payments are suspended whilst a Participant is undertaking an approved Leave of Absence. Most grievances are resolved informally, through discussion with the involved parties.</li> </ol>
	2. Where the Participant is dissatisfied with the outcome, they may apply to the Student Ombudsman for Level Two – Formal Resolution of Grievance, or the Student Ombudsman may determine that it is appropriate to progress the matter to Level Two.
	<ol> <li>Where the grievance is not resolved at Level Two, the Participant may request that the Vice-President (Administration) and University Registrar progress the grievance to Level Three – Formal Grievance Determination. The request must be made within 10 working days of notification of the outcome at Level Two.</li> </ol>
