

McGrathNicol Indigenous Scholarship in Investigations and Intelligence

Terms and conditions

Overview

The McGrathNicol Indigenous Scholarship in Investigations and Intelligence (*‘the Scholarship’*) is an industry scholarship valued at \$14,000, offered to commencing OR continuing domestic students. This is provided to the Participant via funds transfer to their nominated bank account.

These terms and conditions apply to Participants commencing the Scholarship in 2024. The Scholarship requires an application and is offered from Session 4, 2024.

Purpose

With the introduction of QUT’s new Graduate Certificate in Investigations and Intelligence in 2024, McGrathNicol are eager to support new students entering the field of investigations who come from diverse backgrounds, and with a particular focus on supporting Indigenous Australian students.

Investigators and intelligence analysts are vital to ensure proper investigation of issues and to develop strategies and solutions that resolve public and private sector issues such as non-compliance to regulations, fraud, scams, and breaches of legislation. As the demand for professionals in investigations and intelligence fields increases, so too does the need for such professions to be inclusive and representative of the communities in which they operate.

McGrathNicol wishes to support QUT in its efforts to attract, retain, support, and develop Indigenous Australian talent, thereby creating inclusive environments that empower a strong, supportive, and diverse community.

McGrathNicol also recognises that financial challenges faced by many Indigenous Australian students when undertaking further study. This scholarship opportunity seeks to dismantle such barriers to entry.

Therefore, in the hope of fostering a more inclusive and representative workforce in the investigations and intelligence landscape, especially for Indigenous Australian people, McGrathNicol intends to establish the McGrathNicol Indigenous Scholarship in Investigations and Intelligence.

Part 1 <i>Eligibility Requirements</i>	To be eligible for the Scholarship, Participants must satisfy the below eligibility requirements: <ol style="list-style-type: none"> 1. Must be an Aboriginal and/or Torres Strait Islander Person as defined under Section 5 of the Confirmation of Aboriginal and/or Torres Strait Islander Descent Policy and have had a processing officer from the Oodgeroo Unit or Carumba Institute confirm Aboriginal and/or Torres Strait Islander descent via the Confirmation of Aboriginal and Torres Strait Islander Descent (CATSID) procedure.

JQ20 Graduate Certificate in Investigations and Intelligence. 3. Must comply with QUT's scholarship, bursary, and prize concurrency conditions.
<p>Part 2 <i>Application and Selection Criteria</i></p>	<ol style="list-style-type: none"> 1. The Scholarship requires an application form. Due to the specific nature of the Scholarship, the Participant must provide: <ol style="list-style-type: none"> a. Academic transcript and/or letter from employer supporting the Participant undertaking the JQ20 Graduate Certificate in Investigations and Intelligence award course and application for the Scholarship b. Written response to the selection criteria: <ol style="list-style-type: none"> i. the Participant will be required to respond in short form to a questionnaire about the Participant's professional attributes, career aspirations, interest, and intentions for studying and working in investigations and intelligence. 2. The Participant may be invited to attend an interview at QUT or off-site location. <ol style="list-style-type: none"> a. The Participant may be required to supply evidence to support claims made on their application at the interview. Where the Participant is unable to supply appropriate or compelling evidence in support of their claims, QUT reserves the right to award the Scholarship to the next highest ranked applicant. 3. Applications must: <ol style="list-style-type: none"> a. Be submitted by the closing date b. Include any and all supporting documentation in the correct form c. Be written in the English language. 4. By applying for this Scholarship, the Participant warrants that they have read, understood, and agree to be bound by these terms and conditions. 5. QUT has discretion with any decisions made, in connection with this process. To the extent permitted by law, QUT has no liability to any Participant for decisions made in relation to the Scholarship.
<p>Part 3 <i>Value and Payment of Scholarship</i></p>	<ol style="list-style-type: none"> 1. Scholarships valued at \$14,000 are paid at \$14,000 per year for a standard full-time enrolment program (36 credit points or more) or part-time enrolment program (24 credit points or less) for a maximum of one (1) year. Payments are made per quarter (\$3,500 per teaching period) and are disbursed the week after the census date of each teaching period. 2. For the purposes of these terms and conditions, <i>teaching period</i> means the Session 1, 2, 3, and 4 teaching periods. Payments will not be made to Participants during the Summer Program, or any other teaching periods designated in Grouped Period 3 (Summer Cluster), unless otherwise specified in the Scholarship offer letter. 3. Participants who complete their studies in accelerated mode or before the term of the Scholarship lapses will forfeit any remaining balance of the Scholarship. 4. Participants enrolled in a part-time enrolment program will receive 100% of the payment to which would be received if undertaking a standard full-

	<p>time enrolment program.</p> <ol style="list-style-type: none"> 5. Payment is subject to the <i>Conditions of Scholarship</i>. If the Participant fails to adhere to the <i>Conditions of Scholarship</i>, payment may be suspended or terminated. 6. Participants will receive payment by electronic transfer to their nominated bank account after the census date of each teaching period. 7. Participants enrolled in Exchange, Cross Institutional, and/or Brisbane Universities Language Alliance (BULA) units will receive payment after the census date of the Exchange, Cross Institutional, and/or BULA units. 8. Whilst every care is taken to ensure payment is correct, Participants are required to monitor payments and notify the Scholarships team (scholarships@qut.edu.au) of any over or under payments. 9. Overpayments: <ol style="list-style-type: none"> a. If an overpayment occurs at any time and for any reason, QUT may issue the Participant with a written notice requiring repayment of the amount overpaid ('Overpayment Notice') b. The Participant must pay to QUT the amount of the overpayment specified in the Overpayment Notice within ten (10) business days of the date of the Overpayment Notice. c. QUT may, at its sole discretion, recover the overpayment specified in the Overpayment Notice from the Participant by offsetting that overpayment against any amount subsequently due to the Participant as part of their Scholarship. 10. Taxation: QUT does not withhold PAYG tax from coursework scholarship, bursary, or prize payments. It is the Participant's responsibility to check the tax implications for their scholarship, bursary, or prize and personal circumstances. Centrelink: Centrelink may include this Scholarship entitlement in any means testing for applications made for Commonwealth assistance. Participants are encouraged to check the Centrelink website for information regarding exemptions.
<p>Part 4 <i>Term of Scholarship</i></p>	<ol style="list-style-type: none"> 1. The term of the Scholarship will be for one (1) year, for both a standard full-time enrolment program and part-time enrolment program.
<p>Part 5 <i>Conditions of Scholarship</i></p>	<ol style="list-style-type: none"> 1. Participants must remain admitted and enrolled in an eligible award course to receive payment. See <i>Eligibility Requirements</i> for the definition of eligible award course. 2. Participants are not permitted to change their award course and continue to receive the Scholarship, unless otherwise specified in the Scholarship offer letter. 3. Deferment of the Scholarship offer is not permitted. 4. Payments are suspended whilst a Participant is undertaking an approved Leave of Absence. After completing their first teaching period, Participants are eligible to apply for up to two (2) years Leave of Absence from their award course without impacting their Scholarship entitlement. 5. Participants who withdraw from their award course or units prior to the

Special circumstances will be taken into consideration to support individual variation to the <i>Conditions of Scholarship</i>. Supporting documentary evidence may be requested. Participants are encouraged to discuss their special circumstances with the Scholarships team (scholarships@qut.edu.au), Faculty, or QUT Student Services. 7. Participants of the Scholarship cannot concurrently receive another merit, cooperative, or industry scholarship, but are eligible to receive a bursary, prize, or equity scholarship, whilst in receipt of the Scholarship. 8. Unsuccessful applications: <ol style="list-style-type: none"> a. QUT's decision in the awarding of the Scholarship will be final b. Accept the Scholarship and agree to the declaration and terms and conditions in the online offer acceptance form by the date specified b. Provide QUT with student bank details. 10. If the Participant does not accept the Scholarship by the date specified in the offer letter, the Participant will forfeit the Scholarship and QUT reserves the right to allocate the Scholarship to another person.

If the Participant is under the age of 18 years, the Participant will be deemed to have obtained the permission of the Participant's parent or legal guardian to participate in the Scholarship application process and the Scholarship award and to be bound by these terms and conditions.
<p>Part 7 <i>General Requirements for Application Terms</i></p>	<p>Where an application is required:</p> <ol style="list-style-type: none"> 1. All applications become the property of QUT upon submission, upload or otherwise. 2. Applications must be received by QUT during the application period. 3. A student claiming to be a Participant must provide proof of identity, if required by QUT. 4. Each Participant may be required to sign a document indicating that they have received their Scholarship payment at the time of payment. 5. Any decision of QUT, the Scholarship sponsor or donor, in respect of all matters arising out of, or in connection with, the Scholarship is final and binding and no correspondence will be entered into. <p>Part 8 <i>Termination of Scholarship</i></p>	<p>QUT reserves the right to cease the Scholarship awarded to a Participant in the following circumstances:</p> <ol style="list-style-type: none"> 1. Failure to comply with the <i>Conditions of Scholarship</i>. 2. Withdrawal from award course. Participants are advised to contact the Scholarships team (scholarships@qut.edu.au), Faculty, or QUT Student Services before withdrawing from their award course. 3. Failure to enrol into an eligible award course following the completion of the approved offer deferral period. 4. Commencing an award course at another higher education provider during the approved offer deferral period. 5. Failure to enrol into an eligible award course following the completion of the approved Leave of Absence period. 6. Engaging in behaviour that breaches the QUT Student Code of Conduct, where if proven would be regarded as student misconduct. The required standards of behaviour are contained within the Academic Integrity Policy, the QUT Code for Responsible Conduct of Research, and the Acceptable Use of Information and Communications Technology Resources Policy.
<p>Part 9 <i>Grievances and Appeals</i></p>	<p>Where the Participant intends to lodge an application for a grievance:</p> <ol style="list-style-type: none"> 1. Participants should initially contact the Scholarships team (scholarships@qut.edu.au) or Student Ombudsman to undertake informal resolution of grievance prior to requesting formal resolution of grievance (Level One – Informal Resolution of Grievance). Most grievances are resolved informally, through discussion with the involved parties. 2. Where the Participant is dissatisfied with the outcome, they may apply to the Student Ombudsman for Level Two – Formal Resolution of Grievance, or the Student Ombudsman may determine that it is appropriate to progress the matter to Level Two. 3. Where the grievance is not resolved at Level Two, the Participant may request that the Vice-President (Administration) and University Registrar progress the grievance to Level Three – Formal Grievance Determination. The request must be made within 10 working days of notification of the outcome at Level Two. 4. Any grievances related to the administration of scholarships, bursaries, and prizes are governed by the Grievance Resolution Procedures for Student Related Grievances. <p>Where the Participant intends to appeal a matter:</p> <ol style="list-style-type: none"> 1. Participants should initially contact the Scholarships team (scholarships@qut.edu.au) to appeal a scholarship matter. 2. Where the Participant is dissatisfied with the outcome, they may apply to the Scholarships team (scholarships@qut.edu.au) to appeal a scholarship matter to the Appeals Committee. 3. Any appeals related to scholarship, bursary, and prize matters are governed by these terms and conditions, the University Committee Governance Policy, and the Appeals Committee Charter.

<p>Part 11 <i>Reserving the Right to Amend</i></p>	<p>Without limiting any part of the Scholarship terms and conditions, QUT may:</p> <ol style="list-style-type: none"> 1. Amend or replace these terms and conditions, or any Scholarship rules or procedures, at any time and for any reason. 2. Extend, suspend, or terminate the Scholarship or Scholarship process at any time before the Scholarship is awarded. 3. Accept applications after the due date. 4. At any time prior to awarding the Scholarship, disqualify any Participant from participating or exclude their offer from further consideration. 5. Commence a new process for calling applications on a similar or different basis to that outlined in these terms and conditions. 6. Use non-QUT personnel in assessing applications.
