Report from University Academic Board on academic governance activities

Council noted the key matters actioned by the University Academic Board at its 19 November 2024 meeting, including the update on a strategic academic discussion focussed on QUT Sport, which included an update on activities that involved engagement with students; the impacts on Generative Artificial Intelligence (GenAl) in learning, teaching, and assessment; student attraction and retention; and impacts of the introduction of the new National Student Ombudsman.

Council noted the *confidential* update on the QUT Campus Master Plan. Council further resolved to note the approach and consultation undertaken to review QUT's Campus Master Plan, proposed concepts, catalyst projects, and next steps.

QUT Financial Plan - 2025 - Confidential

Council resolved to approve the QUT Financial Plan – 2025 as represented in the report. Council further resolved to approve an additional amount of 2025 Physical Program expenditure in the event that expenditure carries over from 2024 to 2025.

Investment and Borrowings Performance Report

Council resolved to note the investment and borrowings performance for the period ended 30 September 2024.

QUT Student Guild - Annual Audited Financials (1 July 2023 - 30 June 2024)

Council resolved to note the Audited Financial Report of the QUT Student Guild for the period 1 July 2023 to 30 June 2024. Council requested the QUT Student Guild report back to them on specific matters within the financials.

QUT Related Parties Register – Update

disclosures of relevant interests set out in the agenda to ensure that QUT can update the QUT Related Parties Register and report any related party matters in the 2024 annual financial statements.

Annual compliance review – Voluntary Code of Best Practice for the Governance of Australian Universities

Council resolved to approve the new QUT Council Charter, to be published in the committee charters module of the Manual of Policies and Procedures (MOPP) and to approve the rescission of the policy, QUT Council. Council noted the transfer of sections relating to honorary doctorates and Life Fellowships, currently in the QUT Council policy, to the Digital Workplace and public website.
