

# QUT LANDSCAPE ARCHITECTURE CENTENARY FUND SCHOLARSHIP TERMS AND CONDITIONS

## **GENERAL**

- 1. Closing date for applications is 5pm, 8th March 2020. Late applications will not be accepted.
- 2. To be eligible for the QUT Landscape Architecture Centenary Fund (QLACF) Scholarship applicants must meet the following criteria:

#### Student Profile

#### You must be:

 About to undertake your final year in a Bachelor of Design (Landscape Architecture) at QUT.

#### Academic Profile

#### You must also be:

- currently enrolled full-time at QUT;
- have achieved a GPA of more than 5.8;
- intend to graduate with your degree in the minimum time for completion.

## Citizenship Profile

## You must also be:

- an Australian or New Zealand citizen;
  or
- a permanent resident; or
- the holder of a permanent humanitarian visa: or
- an international student who has completed high school in Australia.
- 3. Applications are only open to domestic and international students who have completed their secondary studies in Australia.

## A. ENROLMENT

- 4. Recipients must remain enrolled as a full-time student at QUT for the duration of the studies to retain their scholarship.
- 5. After first semester, students are able to take approved Leave of Absence for up to 12 months (in accordance with QUT Student Rules) and still retain the scholarship. Scholarship payments will not be made to the scholar while on an approved Leave of Absence.

## **B. RECIPIENT PERFORMANCE OBLIGATIONS**

6. All QLACF Scholarship recipients must maintain a course grade point average (GPA) of 5.8 or greater in any given semester to maintain the scholarship for the next study period. Failure to maintain this condition may result in the scholarship being terminated.

## C. SCHOLARSHIP VALUE AND DISBURSEMENT

- 7. The scholarship valued at \$10,000 will be paid in two instalments of \$5,000 each at the conclusion of each semester (week 13).
- 8. While every care is taken to ensure direct payments of scholarship funds are correct, scholarships recipients are required to monitor payments and notify QUT if any over or under payments occur. If under payments occur, the balance will be paid to the student immediately. If over payments occur the scholarship recipient is required to advise QUT immediately and repay the overpaid amount. They will provide a web link for you to upload your bank account details to QUT for payment.

## D. GRIEVANCES

- 10. All scholarship delivery is governed by the QUT Manual of Policy and Procedures, *Chapter E 11 Prizes, Awards and Scholarships*

#### E. CONCURRENCY

- 11. A QUT student is normally only permitted to hold one QUT merit scholarship at any one time however students may be eligible to hold a QLACF Scholarship and an Equity Scholarship concurrently.
- 12. For all intents and purposes the QLACF Scholarship is classed as an industry scholarship.
- 13. QLACF Scholarship is bound by the Scholarship Concurrency Policy. The QUT Scholarships Concurrency Policy determines whether certain scholarship combinations can be held by a student concurrently. Refer to the concurrency table provided below.
- 14. To determine if a combination of scholarships can be held concurrently be a student, determine scholarship type A on the Y axis and Scholarship Type B on the X axis and slide down and across simultaneously until you reach the concurrency decision for that scholarship combination.
